A couple of years ago, I served on the team for the women's spring walk. During the teaming process, I got to know several people I had not known previously (one of the great joys of teaming!). As teaming progressed, there was one particular woman who I frequently found myself sitting beside during team training or talking with during breaks. During our conversations, I discovered – much to my surprise – that this woman had walked on my walk – E-34. Now that's probably not too unusual; it would be difficult to get to know all 35 pilgrims on a weekend. I was amazed, however, by how different that walk had been for each of us.

As the WLD and ALDs led the team through planning for each part of the upcoming walk, I might say to Ellen, "Oh, I remember that. It was one of the most special parts of the weekend." Then Ellen would look at me and say, "Really? I don't even remember that happening at all." Or perhaps Ellen would say, "I'm really looking forward to hearing this reading again." And I would reply, "Are you sure we had that on our walk?" By the time the team meetings were completed, we had come to the conclusion that there must have been two different walks that weekend! How else could we account for such different memories?

Of course, there was only one walk that weekend. And of course, both Ellen and I participated in all the same events. The Walk to Emmaus is a carefully constructed event and the schedule is the same for every walk, both men's and women's. But Ellen and I are different and God's plan for each of us is different. God gave us each a very special experience – an experience that He created out of His knowledge of us and His love for us.

As you consider sponsoring or teaming on the upcoming spring walks, first give the decision to God. Then as you prepare for the weekend, allow God to direct the experience for each pilgrim. Allow the pilgrims to be themselves in responding to the message and love of God. Don't attempt to recreate your weekend for someone else. Your weekend was uniquely created for you by God. Allow Him to do the same for each one who walks with Him on the road to Emmaus.

EMOTIONAL DECEPTION

"How are you feeling today?" This phrase is often used as a conversational opener and not really as a request for information about "real" feelings. Sometimes a person takes us seriously and we do find out how they are really feeling!

We interpret life and respond to it by our emotions and perceptions. Care and wisdom should be exercised when interpreting and acting upon our emotions. Some are deceptive while others are accurately perceived and ought to be acted on.

For instance some people will commit a crime or live immorally with seemingly no feelings of "guilt." You wonder why their conscience failed to develop a sense of "right" and "wrong." On the other hand some very sensitive people will feel guilty for some small item or statement that is really insignificant.

To complicate life more, a perfectionist may feel "pushed" to go over things that are already in good shape. Some people have feelings of low self-esteem or depression when in reality good things are occurring in their lives. Many Americans "feel" poor when really the average American is rich compared to the average citizen in many other countries. Many experience fears over some activity or situation when a life-time of experiences would prove that similar circumstances have always worked out.

The above examples can be the result of physical causes and require medication. However more often our emotions need to be analyzed through the "eye of wisdom" and acted on accordingly. After carefully reviewing them, we have to do what we know is "right" and "wise" in spite of our emotions. A lot of frustration and negative emotions could be reduced by learning to avoid some of the above dilemmas. Surely God does not want us to be robbed of genuine Christian joy by being victims to emotional deception.

Obviously not all emotions are deceptive and therefore should be enjoyed. Our love for God, family, people and country can and should be experienced and appreciated. When we are not in bondage to a wrong perception of emotions, then we can be free to give and receive positive emotions.

The Lord would have us to be very discerning between emotions that deceive and those which should be legitimately enjoyed. We shall always have emotions, but we can learn to control them rather than vice versa.

Dear Brothers and Sisters in Christ:

The new year brought the airline job that I loved to a halt. I knew it was my last day, and it would be the last day I would work with the wonderful people I had built friendships with during the last three years. It was hard to call it a company. It was more like a family.

Although my last day was sad, it was similar to many other days. The biggest difference being that with every task I performed, I knew it would be the last time I would be working with this family of professionals. As usual, I greeted passengers as they boarded the flights, I served soft drinks to the ones that were awake, I made all of my announcements, picked up trash, passed out mints, made small talk with several passengers, and thanked each of them for flying with us as they left.

After my last flight, I went inside the terminal. There were many tears, well wishes and expressions of fears. Supervisors, department heads, and even the CEO were there shaking hands and thanking everyone for a job well done. They told us we were the best, and it was not our fault the company had failed. It was like attending the funeral of a loved one.

After spending about a half hour in the terminal, I could not stand any more good-byes. I made my way to the main terminal and the parking lot. I drove to headquarters and turned in my Identification Badge and parking pass. It was one of the saddest days I had ever spent at my dream job.

During the days afterwards, I had to remind myself over and over again, "It is over. You will not be going to work there anymore!" Then the realization sank in and worry replaced it. Will I be able to find another job? Will I be able to find a replacement to a job that I was just as excited about on the last day as I was the first? How long will I be without a job? Will I have enough to live on? Will I be able to pay my bills and make my car payment?

As I wallowed knee deep in worry, I was reminded of an incident several months ago when I was driving down a busy highway and stopped at a red light, My wife, Susan, pointed towards the intersection and cried out, "Oh no, the little bird is going to get hit!

She pointed to a tiny blue bird hopping around on the road, gathering a few crumbs. The signal light changed to green, and the cars roared forward. The little blue bird flew up suddenly, avoiding all of the cars, and landed on a canopy covering gas pumps at a nearby convenience store. We determined that it was not a native bird, but a parakeet!"

I turned left at the next intersection and drove back to the convenience store parking lot. Susan and I got out of the car, and casually began calling out to the little blue bird. Passers by just glared at us as we whistled. He chirped in answer. We called to him as if we knew he was tame and was going to fly down to us, but he did not. He stayed on top of the canopy, continued to chirp, as he looked down at us. I guess the once captive bird had found his freedom and intended to protect his liberation at all costs.

It was the end of the summer and fall was rushing in. We knew he was a tropical bird and could not withstand the colder weather that would soon fill our nights and spread into our days.

I found myself still thinking about the fate of that little bird a few days ago, when a thought came to mind. A frown on my face turned to a smile as I realized that I am very similar to that little blue bird. God has promised to take care of me and the little bird. The bible comforts me in Matthew 6:25-26, "Therefore I tell you, do not worry about your life, what you will eat or drink; or about your body, what you will wear. Is not life more important than food, and the body more important than clothes? Look at the birds of the air; they do not sow or reap or store away in barns, and yet your heavenly Father feeds them. Are you not much more valuable than they?"

It is amazing to me, how God placed my life in perspective using the smallest bird to teach me His lesson of love, protection, and grace. All I have to do is have faith.

Directions to Lake of the Woods Church: One Church Lane Locust Grove, VA 22508

The Lake of the Woods church is located approximately 15 miles west of Fredericksburg and 15 miles east of Culpeper off Route 3. Enter Lake of the Woods, (across from Burger King), and tell the guard at the gate you are attending LOW Church. Turn left inside the gate on Lakeview Parkway. Travel for 2.4 miles until you see the sign at Church Lane, then turn left.
